**5. Fire-fighting measures**

**Protective actions during firefighting**

The product is flammable. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Avoid discharge to the aquatic environment. Do not handle broken packages without protective equipment. Do not reuse empty containers.

#### **Advice on general occupational hygiene**
